**RESEARCH INTERESTS:** My research centers on the intersections of gender and religion in the American West, particularly the role of Roman Catholic sisters in public and private life. Gender and religion play a pivotal role in the development of the welfare state, and my research on Catholic sisters' efforts to combat poverty contributes to scholars' understanding of the social and political implications of race and class divisions in California's multiethnic communities during the nineteenth and twentieth centuries.

Through the use of oral history, my current project explores the Daughters of Charity Foundation's efforts to meet poor person's immediate needs through education and social services, while also promoting long-term, systemic changes to reduce poverty and maintain their religious community's sustainability.
